Shall the County of Wagoner, Oklahoma, by its Board of County Commissioners, levy and collect a one quarter of one percent (.25%) sales tax to be administered by the Wagoner County Criminal Justice Authority for the purpose of paying for the costs and expenses of capital improvements to and costs and expenses of operating, maintaining, repairing and remodeling the Wagoner County criminal justice system including specifically any expense incurred in connection with incarceration of prisoners in the Wagoner County Jail, such sales tax to commence on the first day of July, 2024, and continuing permanently until repealed by a majority of electors voting at an election duly called for such purpose?

PROPOSITION NO. 8

Shall Wagoner County, State of Oklahoma be authorized to levy and collect a County lodging excise tax of five percent (5%) which funds shall be used by Wagoner County to encourage, promote, develop, construct, maintain, repair, facilities, trails, access, enjoyment of public spaces, and other recreation throughout Wagoner County in addition to all other city, county, and state excise taxes upon the gross proceeds or gross receipts derived from the service of furnishing of rooms by any permanent structure or recreational vehicle parked in a recreational vehicle park that provides at least one lodging space which the public may, for consideration, obtain sleeping accommodations, with the exception of campsites, within Wagoner County in perpetuity, pursuant to 68 O.S. Section 1370.9; this includes but is not limited to hotel, motel, recreational vehicle parked in a recreational park, short-term rental, resort, vacation rental, cabin, and bed and breakfast; said tax beginning to be collected the first day of the calendar quarter following this election?
