ABSENTEEISM

22% of students in Tulsa Public Schools are chronically absent, missing 15 days of school or more. Absenteeism not only impacts a student's ability to learn and educational outcomes, but also impacts state funding to our schools. Transportation and Mental Health issues are impacting absenteeism.

TRANSPORTATION

Currently, elementary students in Tulsa Public Schools are eligible for bus service if they live farther than 1.5 miles from their schools. The distance increases to 2 miles for middle and high schools. While recommended walking distances vary, these distances are at least half a mile outside of standard practices. Additionally, we heard stories of children running across busy streets to get to school without crossing guards.

- 1. If elected, will you work with ACTION to decrease bus radiuses by half a mile to 1 mile for elementary students and 1.5 miles for middle and high school students? Yes or no.
- 2. If elected, will you work with ACTION and the City of Tulsa to ensure that busy streets where students walk to school have crossing guards, starting with 21st street across from MacArthur Elementary and Hale Middle and High Schools? Yes or no.

You will have 60 seconds to respond.

MENTAL HEALTH

We consistently heard from teachers, parents, administrators, and mental health professionals that our students are dealing with behavioral health challenges at greater levels than in a pre-pandemic world. Recent mental health data indicates that crisis calls for students in TPS have increased exponentially from this time last year.

3. If elected, will you work with us to develop a mental health student advisory board to better understand the mental and behavioral health needs of students with a focus on peer-to-peer prevention? Yes or no.

You will have 45 to seconds to respond.

TEACHER SUPPORT

We consistently heard from teachers the need for smaller class sizes. This will allow teachers to better serve their students' learning and behavioral needs as well as engage with parents. Classroom size caps from the State Department of Education are 20 for kindergarten through sixth grade and 140 per teacher in a six-hour period for seventh through twelfth. We have heard stories of kindergarten class sizes of 30 students, third through fifth grades with as many as 33, and a fourth-grade class of 45.

4. If elected, will you work with ACTION to strategize to incrementally decrease class sizes to State Department recommendations?

You will have 45 seconds to respond.

SCHOOL SAFETY

Students and teachers told us countless stories of fights in hallways, bullying, teachers getting hurt, and fear of gun violence in schools. Last year Senate Bill 100 passed the Oklahoma State Legislature with bipartisan support that mandates school safety assessments every 5 years and provides funds to remedy issues found in the assessments.

5. If elected, will you agree to work with us to utilize resources from Senate Bill 100 to prioritize safety assessments with the Department of Public Safety and implement recommendations for each school in your district? Yes or no.

You will have 45 seconds to respond.

If elected, will you agree to meet with us within your first 100 days of office so that we can get to work on these issues together? Please, just a Yes or no answer.
